On behalf of the River Watch Board of Directors we are hoping that you and your family are faring well during these very unusual and daunting times. We can only hope that a vaccine is found soon that will put an end to these very trying times. Since May the Board of Directors has been meeting virtually through Zoom. All residents are encouraged to attend these meetings which take place on the third Wednesday of each month at 7:00pm. If you would like to participate, directions will be posted on the website as well as the message board at the exit of River Watch.

Throughout this past year the Board has been working on a number of changes within River Watch. One of the positive changes is the sidewalk renovation project. This project is progressing in stages and we hope to complete the final phase right after the first part of 2021. The first phase consisted of grinding those sidewalks that were slightly raised and could be brought within county standards. Additionally, the sidewalks that required replacement were replaced within the projected areas. However, if there are sidewalks that you feel require attention please call McNeil Management.

All of the trees within River Watch have been trimmed to meet Hillsborough County standards.

After 20+ years the gates at the entrance to River Watch have started to look worn. Not so long ago a resident e-mailed that the gates were looking aged. In response, the gates will be removed and rejuvenated!

In this newsletter we are focusing on several issues that are addressed annually. One of these issues is the storm drains. Since we are a private gated community, the storm drains are the property of the HOA. Residents frequently place bags of yard waste on the storm drains. Some residents leave the yard waste on the storm drains several days before the yard waste collection on Tuesday. The waste can be dragged into the storm drains and clog the drains. When this happens, it becomes a costly issue. Please do not place anything on the storm drains or near the storm drains. Remember that your dues are contributing to remedying the issue. It's money that could be spent in more productive ways!

Every resident needs to remember that River Watch is a deed restricted community. You must adhere to the documents. That means that before any alterations are made to your property you must submit an ACC application. This includes roofs, paint, landscaping, etc. If you are in doubt as to whether you need to file an ACC application, please call or e mail McNeil Management and clarify.

Landscape update By Larry Barroner.

Two years ago, I provided an article telling you the number of pine trees along Donneymoor Drive will diminish. An arborist from Brightview Landscape Maintenance determined that an infestation of Southern Sculptured Pine Borer had killed many of the pines trees and will eventually move on to other "host" pines trees. Additional pine trees will be removed as they become infested, and based on the recommendation of our landscape team. Large areas or islands where all of the trees were removed have had sod put down to keep the area looking

Some other projects we have completed include the enhancements to three of the southern entrances along Donneymoor Drive. Based on the recommendations of our landscape team, we chose some Florida friendly perennials that should last a long time. We also lifted the canopies on our 132 live oaks trees that line Donneymoor Drive, this structure pruning gave us the proper height for large box trucks to come and go without damaging the trees or their vehicles.

Our community landscape is dependent on our irrigation system to keep common areas looking green. Our system is aging and as those 132 live oak trees continue to grow, they cause leaks in the irrigation system. If you ever notice leaks, (e.g. unexplained running water on a dry day in the gutter of Donneymoor Drive), other issues with the irrigation system, (e.g. broken sprinkler heads or spraying on the street) or issues with the landscape, please contact our property manager at Green Acres Properties. jgrass@greenacreproperties.com

It doesn't take much to remember that we have pets in our community. In fact, if you don't watch your step, you're liable to step in one such reminder!

Besides being unsightly and smelly, animal waste can be hazardous to the health of our children who play in the community and other pets. One of the most common forms of disease transmission between dogs is through fecal matter.

When walking your dog in our community, remember that it should be leashed. Also, it is important to remember to immediately clean up after your pet. Take along a baggie with you to pick up waste with and then dispose of it properly. Multiple trash receptacles can be found throughout our community common areas.

By taking a few simple steps to clean up after your pet, you can contribute not only to the beautification of our community, but also towards the elimination of one of the most irritating nuisances in our community. Thank you for your cooperation!

Timely Assessment Payment Saves Us All Money!

In order to meet its financial obligations, our association depends upon the timely receipt of our quarterly assessments from the owners.

When our community's budget is approved by the Board, it assumes two things: the

amount of income must equal the amount of expenses, and, that each homeowner will pay their maintenance assessment in a timely manner. If one or the other fails to happen, we have a cash-flow problem and it usually results in costing all of us more money in the long run.

Our community depends entirely upon the quarterly assessments to pay its bills

(insurance, landscapers, electricity, management, etc.). Whenever homeowners

are delinquent in paying their assessments it creates a "cash-flow shortage" that may

prevent the association from paying its bills in a timely manner. There is no other source of income available to make up for the shortage. If we "borrow" money from the reserves to pay for operating expenses, we are required to pay it back, thus we create even more expenses.

Ultimately, when even a few homeowners fail to pay their assessments on time it ends

up costing us all more. That is because since most of our expenses are pre-determined, the only way to make up for a cash-flow problem is to increase the amount of money coming in, or in other words, raise our quarterly assessment amount.

We can all take part in keeping our community's expenses down, and one of the best way is to make sure that your \$85.00 quarterly assessment check is sent on time!

Storm Drains

Within the last few months, several storm drains in the community became clogged and caused street flooding. The cost of cleaning out those storm drains was paid by the Riverglen homeowners.

During downpours like those that we often experience throughout the rainy season, any objects that are placed on or in the drains are easily dragged down into the pipes and can sometimes cause a blockage. Besides the flooding problems that can occur, anything that goes down the storm drains generally ends up in one of the community retention ponds. Yard waste, chemicals, trash, paper, cleaning products, plastic bags, plastic ties, etc that are carried into the retention ponds can cause harm or death to the fish, birds and other wildlife that reside in and around those ponds.

Residents and lawn services should also be aware that blowing any yard waste or refuse into the storm drains is



also a violation of the deed restrictions.

So any time you (or anyone else) blows yard waste into a drain, or piles debris on the drains, remember that the cost of cleaning out that drain comes from the dues that you pay.

Two (very easy) ways to help keep your community safe

Report malfunctioning streetlights. There is a very simple online form available on the Tampa Electric website: https://secure.tampaelectric.com/tampaelectricsecure/forms/residential/streetlightout/

If you notice a streetlight not working, note the number on the pole and submit the online form. Response time is usually very good – lights are usually repaired in a week or two, often within just a few days.

Report potholes. The roads within the Riverglen community (except within River Watch) are maintained by Hillsborough NOT the Homeowners' County, Association. Potholes often develop on Donneymoor Drive and they can get big and deep very quickly. Please report any issues promptly so that repairs can be made before they become a hazard to vehicle traffic. The county website has an online form for reporting road issues: https:// service.hillsboroughcounty.org/311/roadssidewalks/

Parking restrictions – trailers, RVs, and Boats

The Riverglen Declaration prohibits overnight parking of trailers, RVs, and boats, unless they are in garages or completely screened from view. The restriction also applies to commercial vehicles over one ton. The restriction applies to the entire community, including streets and driveways.

There is an exception allowed for "... temporary nonrecurrent parking...". To comply, the parking must be both – temporary and nonrecurrent.

"Temporary" is further defined in the paragraph as less than 48 hours. So any time the vehicle (boat, trailer, etc.) is parked for more than 48 hours, it would not be considered temporary, and would be a violation.

Another condition for compliance is that the parking must be "nonrecurrent". So, if a boat or trailer is parked overnight every weekend, that is a recurring event, and is not in compliance with the pertinent Declaration, even if it is there for less than 48 hours at a time.

The deed restrictions address the issue of overnight parking. Because River Watch HOA is a gated community, the streets are private (not the responsibility of Hillsborough County). The deed restrictions specifically address no overnight parking. Cars that are left on the streets of River Watch overnight will be subject to towing.

Probably the issue that is truly abused within River Watch is speeding. The most appalling fact is that many of the speeders are parents of young children. The speed limit within River Watch is 25 mph. Please adhere to the speed limit.

There are many residents within River Watch who serve the community tirelessly. Susan Flynn served



as a member of the ACC and recently, she served on the Board of Directors for several years. She left the BOD this year and the BOD would like to thank her for all of her hard work on

the BOD and the ACC. It should also be mentioned that Dawn Callao who has served as the chairperson of the ACC for several years, recently resigned to pursue other interests. The BOD would like to thank Dawn for her all of the time and energy that she gave to River Watch. It should be noted that although she has resigned from the ACC, Dawn and her husband Carlos who are retired members of the military, continue to be responsible for the care and attention of the American Flag that flies at the entrance to River Watch. The BOD and residents are grateful to them. Still more residents to thank are Jenn Defreese and her husband Rob. Every year they decorate the front entrance for the holidays and before you know it, Jenn and Rob will be decorating! Kara Rutherford has been the chairperson of the welcoming committee for some time and she recently decided to resign that position and take on the chairmanship of the yard sales. Kara is another resident who gives her time to River Watch freely. Last but certainly not least to thank is Becky Clemments. She went door to door for several months gathering signatures to ensure that the amendments would pass. She invested a tremendous amount of time speaking to residents explaining the significance of the amendments. She was the single motivating force in attempting to get the amendments passed. The BOD is deeply grateful to all of these residents.


We are seeing recommendations to now have at least 7 days of resources on hand.

Plan for a place to go and a means of transportation that will provide appropriate protection/isolation from COVID. Make sure you have sufficient masks on hand for the situation.

- Sign up for HCFL Alert
- Know Your Evacuation Zone
- Think about options for your pet
- Register for a special needs shelter

River Watch Amendments Written by Becky Clemments

Question: What's the difference between a Proxy and an Absentee Ballot?

Answer: Nothing!

Earlier this year letters with suggested amendments to the River Watch deed restrictions along with proxies went out to all RW homeowners. Very few of them came back, but a dedicated group of volunteers went door knocking to collect the proxies (thank you!) Some residents regarded the proxies as granting "too much power to the HOA". Given that we are all members of the HOA, these proxies were a very good way for our voices to be heard.

The amendments were intended to bring the deed restrictions into compliance with current FL statutes, clarify who is responsible for certain maintenance items, and to save a significant amount of money for our HOA over time.

The good news is that there were enough proxies to hold an Annual General Meeting (AGM) in January. The Board of Directors (BOD) was able to conduct business and listen and respond to concerns brought up at the meeting. This also granted an additional 90 days to collect more proxies, but Covid-19 hit and the BOD could not hold another AGM or continue to personally collect proxies.

Given that we were short about 60 votes, the suggested amendments did not pass. As this was a painstaking, very long legal process, I believe it is unlikely the BOD will try again any time soon. For my part, I enjoyed meeting my neighbors as I went collecting, but sometimes disappointed in the lack of response. If the BOD does try to pass amendments in the future, please read the material, vote your proxy and return it. Better yet, join in a Board meeting any month and make suggestions proactively. Suggestions are always welcome, as are helping minds and hands.

In any event, your comments and concerns are always welcome. Feel free to call or email our property manager company [McNeil Management (813) 571-7100; management@mcneilmsi.com] and they will pass them along to the Board

Remember – we are all members of the River Watch HOA, and the BOD is composed of volunteers working hard to keep our neighborhood a lovely place to live in.

Stop signs have been posted at strategic locations within River Watch. The stop signs are there for everyone's safety and all of us need to remember this. Please do your part by observing the speed limit of 25mph and also coming to a full stop at the stop signs. River Watch is trying to be proactive in preventing tragic accidents!

TREE CARE TIP: AVOID "HURRICANE PRUNING"

UF IFAS Extension UNIVERSITY of FLORIDA

This is a good time to remove weakened or diseased limbs on trees that could pose a risk during a major storm. Experts warn, however, against the common practice known as 'hurricane pruning or trimming,' a practice commonly promoted this time of year.

According to the untrained tree trimmer, hurricane pruning is the cleaning out the interior of a tree's crown to allow wind to easily pass through the tree and reduce the risk of the tree breaking up or falling over in high winds. According to University of Florida's Institute of Food and Agriculture Sciences (IFAS), hurricane trimming not only fails to live up to these claims but also places the tree in greater jeopardy.

Wind tunnel experiments at the University of Florida confirm the removal of foliage from the interior increases the likelihood of damage from high winds. Property owners who pay for hurricane pruning are at best throwing their money away while increasing the likelihood their tree will become a hazard.


If you want to protect a large tree, have a certified arborist review your tree and review whether any structural trimming is required, the pros and cons of a lightning rod tree protection, and any other recommendations.

Are you Ready?

Storm season is here. Be prepared. With tropical weather swirling in the Atlantic Ocean, Caribbean Sea, and Gulf of Mexico, it's time to review your plan in case a big storm heads this way. We want you and your family to be ready. Now's the time to prepare for hurricane season, before forecasters begin tracking ominous tropical weather moving toward West Central Florida.

Evacuation Zones vs. Flood Zones

Though they are often mistaken for each other, Flood Zones and Evacuation Zones are two very different things that measure very different conditions. So what's the difference? And when do you use them? Here is what you need to know:

Evacuation Zones

These are the areas that officials may order evacuated during a hurricane. These zones are mapped by the National Hurricane Center and indicate areas that will be affected by storm surge - storm-driven waves that can inundate a community, and threaten lives. Zones in Hillsborough County are identified from A - E, and there are parts of the county that are not in an evacuation zone.

Flood Zones

These federally identified zones indicate a property's risk for flooding at any time of the year, including as a result of heavy or steady rain. This zone has nothing to do with hurricanes or other emergencies, and everything to do with your property insurance and building requirements. Nationally, these zones are classified as Zones A (Special Flood Hazard Area), B, C, D, V and X. Every property is in a flood zone. 

Bugged By Mosquitoes?

Hillsborough County monitors complaints about mosquito populations and uses the information to direct mosquito-control



efforts, including application of pesticides at street level or from the air. Additionally, they offer free on-site inspections from the Mosquito Control and Aquatic Weed Unit and they suggest ways to control mosquitoes in your neighborhood. Are you bugged by mosquitoes? We're Talking Trash

► My garbage was not picked up, who do I call?

Contact Republic Waste, our franchise collector, at (813)265-0292 or you can contact the Hillsborough County Public Works Department, Solid Waste Management Division at (813)272-5680

- ► What about Pick-Ups on Holidays? There is no garbage, recycling or yard waste collection on the following holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day. There are no holiday make-up days for the collection of residential garbage, recycling or yard waste. Services will resume on the next regularly scheduled collection day.
- ▶ How much yard waste is acceptable for curbside collection? You may set out up to twelve (12) 30-gallon containers of yard waste (branches, limbs, grass clippings, shrubbery, etc.) cut to 4-ft. lengths and no more than 6 in. in diameter, neatly stacked, bundled, and/or bagged, for collection. The weight of each container, bundle, bag, or item must not exceed 50 lbs. Place yard waste at the curb away from the garbage cart (i.e. on the opposite side of the driveway.
- What kinds of garbage can I put in the garbage cart? All household garbage items may be placed in the cart. If it's not in the cart, it WILL NOT be picked up! Mattresses, furniture, toilets, old TV's, etc. WILL NOT be picked up. It is recommended that garbage items be bagged and tied first, then placed in the roll cart. This practice will keep your container cleaner and minimize odors. Do not load your container with ashes or coals, recyclable items, household hazardous chemicals or medical waste, tires, paint, or any yard waste such as bagged or loose grass, leaves or small branches.
- ▶ How do I dispose of garbage that will not fit in my 95-gallon roll cart? Bulky items that do not fit in your cart can be disposed of at any of the County's Community Collection Center located on Linebaugh at no additional charge. Or, you can contact Republic Waste to request a Special Collection Service. There is a fee for this service.
- ▶ What if I am disabled and cannot take my roll cart to the curb? Disabled customers may apply to the Public Utilities Department for disability backdoor service. Residents who qualify through the application process will receive the backdoor service at no charge.
- ▶ What if the cart needs repair? Contact Republic Waste, our franchise collector, at (813)265-0292. The Franchise Collector will repair or replace a roll cart within three days from the date of request for repair, or on your next garbage collection day. Having problems? Contact: Solid Waste Management Division at (813)272-5680.
- ▶ What if my cart is stolen, lost, or missing? Contact Republic Waste, our franchise collector, at (813)265-0292. A Sheriff's report will be filed, and a replacement roll cart will be delivered by the Franchise Collector within three days from the date of notification or on your next garbage collection day.
- ► If I move, should I take my carts with me? No. The roll carts should remain at the address they were delivered.
